*Student's Personal Imprest Account is for his/her Personal Expenses . A minimum balance of Rs.5,000/- must be maintained at any given point of time during the year. Imprest Deposit must be replenished as and when demanded by the School. The following costs may be charged to the imprest account.

- A. Uniform/Quilts/Blankets
- B. Textbooks / Stationery/Telephone/Photocopy
- C. Educational Tour / Field Trips/Adventure Camp / Treks
- D. Drop/pickup to/from Chandigarh airport or railway station, etc.
- E. Examination Fee paid to respective Boards
- F. Medical requirements.
- G. Academic activities outside of the standard curriculum
- H. Escort charges for students travelling home for vacation and otherwise
- I. Personal requirements viz. toiletries, repair to personal belongings, etc.
- J. Any other expenses, not specially included above

Fee Rules

- a. The Fee amounts are subject to revision, as advised by the School and Management, from time to time.
- b. Parents are requested to pay the Fee before the due date. Payment after the due date shall entail an interest of 2% per month on the amount of arrears. Non-payment within 3 months from the due date, shall entail a further of 4% interest per month and may lead to child's name being struck of the Rolls of the School, at the discretion of the Principal
- c. All fees are to be paid in two equal installments. The first installment is to be paid at the time of admission and the second installment is due by the 10th September.
- d. The submission of 'Application for Registration' Form and Registration Fee does not guarantee admission.
- e. A sibling discount of 10% on Annual Boarding and Tuition Fee is granted to the younger sibling, as long as an elder sibling is a student of The Plenum School. The discount will be applicable only if the fee is paid within the stipulated period.
