**FORWARDING OF COMPENDIUM OF ALL WELFARE SCHEMES,
PERTAINING TO VETERANS, WIDOWS & DISABLED SOLDIERS AND THEIR WARDS**

Please refer to your letter No B/45322/AG/R&W-1 dated 31 Jan 2019.

2. The various welfare schemes pertaining to Veterans, Widows and their wards of the State of Meghalaya is furnished as under:-

- (i) Old Age pension of Rs 200/- is provided to male and female citizen old aged 65 and 60 years respectively common to Meghalaya State.
- (ii) Funeral expenses for the Ex-servicemen/their families/Widows Rs 3000/-.
- (iii) Old Age Pension of Rs 10,000/- to World War -II Veterans and their Widows.
- (iv) Free legal aid to Ex-servicemen/their widows
- (v) War Jagir Allowance of Rs 1000/- p.a to parents who sent their only or all son(s) to the Armed Forces.
- (vi) Permit to run taxi service and other transport.
- (vii) Permit for Fair Price Shops on priority.
- (viii) Ex-gratia grant of Rs 15 lakh to NoK of Martyrs.
- (ix) Ex-gratia Rs 5 lakh paid to permanently disabled by injuries inflicted or caused in Consequences while defending the sovereignty and the territorial integrity of India.
- (x) Cash Grant of Rs 1 lakh paid to soldiers who sustained injuries in terrorist/militant related operations.
- (xi) Preference in allotment of Jai Jawan stalls and Kerosene Oil Agency.

- (xii) Cash grants is being paid to Gallantry Award Winners. The same is in process of enhancement of the scheme from the existing rates by the State Govt.(both copies enclosed)
- (xiii) The Sainik Rest House, Shillong is in the process of the approval from the State Govt.
